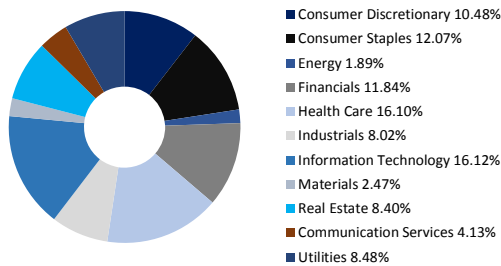

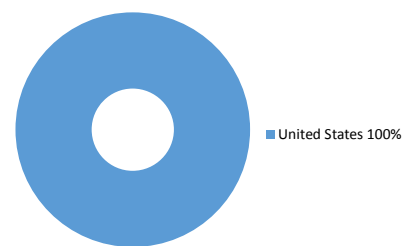

#### Glossary

##### Low Volatility

Volatility is a statistical measure of the dispersion of returns for a given security or market index. A beta of less than 1 means that the security will be less volatile than the market. A beta of greater than 1 indicates that the security's price will be more volatile than the market. The Fund will target an average beta of approximately .75

##### Dividend Yield

A financial ratio that indicates how much a company pays out in dividends each year relative to its share price.

##### Covered Call Option

A call option that is covered by the underlying equities in the portfolio.

##### Premium Income

The income received by writing / selling an option.

#### Manager Commentary

December 2018 proved to be one of the most difficult months for stocks in decades. The Dow Jones Industrial Index fell 8.7% and the S&P 500 fell 9% over the month, as concerns about rising US interest rates and the effects of the continuing trade war with China weighed on equity markets. December saw a sharp increase in volatility, as investors grappled with signs of a global economic slowdown, concerns about monetary policy, political dysfunction, inflation fears and worries about increased regulation of the technology sector. The S&P 500 was up or down more than 1% nine times in December alone, compared to eight times in all of 2017. Only two S&P 500 sectors turned in positive performance in 2018; Health Care and Utilities. The Low Volatility Income Fund slipped lower over the month of December but outperformed the three major U.S. Indexes. The Funds top sectors are Information Technology, Health Care and Consumer Staples. Our top five holdings are Coca-Cola, McDonalds, Pfizer, PepsiCo and Waste Management
